The PTPTN organised the "Majlis Mesra Bersama Pelanggan 2024" event to thank its customers, including government departments, government agencies, private organisations, strategic partners and the media for their continuous support in enhancing its services. Guests attending the event included Datuk Noli Lisa, Chairman of the National Higher Education Fund Board, Chief Executive Officer Ahmad Dasuki, members of the management team and senior departmental officials. The Authority also received donations to myWaqafPTPTN from a number of corporate institutions, including UOB Islamic Asset Management Company, Saturna Company, Uda Holdings, Principal Islamic Asset Management Company, Ninja Logistics Company and Muamalat Bank. myWaqafPTPTN, launched on 11 March this year, is a joint initiative of the National Higher Education Funding Board (HEFB) and the Malaysian Religious Funds Board (YWM) to help alleviate the financial burden of repaying their tertiary loans. "The Higher Education Fund Board is calling for support for myWaqafPTPTN religious donations, which are exempt from income tax of up to 10%. In addition, as an institution committed to strengthening the national higher education agenda, the Department has also distributed RM5,000 to 10 outstanding students, five from the National University and five from the Islamic University of Science, in the form of an SSPN Prime savings account.
